# Oasis Montaj / UX-Analyze

- ❑ Most recent EDQW validated version – 2022.1
- ❑ EDQW validation for 2022.2, 2023.1, and 2023.2 is pending

# USACE GIS Working Group

- ❑ Led by USACE EMCX (Elise Goggin)
- ❑ Purpose: Clarify and standardize SDSFIE data structure for MMRP
- ❑ No NAOC involvement in working group expected
- ❑ In FY25 an RI/FS project may have an additional task to develop revised GIS layers based on working group design
- ❑ After that task has been completed the new data structure, the EM CX plans to ask NAOC companies to review it and provide comments
- ❑ Eventually the new data structure will become a requirement in MMRP PWSs

# Miscellaneous Topics 1

- ❑ Draft QSR Appendix B and C
  - ❖ Goal for a QSR 3.0 draft for review was end of March, but that time frame may be delayed
- ❑ EM 200-1-15 – The document passed legal review and is expected to be signed soon as interim guidance.
- ❑ Steep Slopes requirements – EM CX is looking into it with overall USACE safety in mind
- ❑ MR-QAPP Toolkit Module 2 has been available for >6 months. EDQW will be looking for feedback and suggestions for improvement from NAOC
