








USACE Organizations with Responsibility for M2S2 Activities

- **Overseas Work**
 - Afghanistan, Jordan, Japan
 - Mine Risk Education
- **Policy**
 - MMRP Remedial Action Objectives – Anticipate another 1 year extension
 - Revisions to Corps Guidance
- **Quality**
 - Implement new MMRP UFP-QAPP template to improve QA/QC processes
- **Technology**
 - Promote Advanced Classification tech transfer across multiple programs/projects
 - Support training objectives across multiple platforms (webinars, cloud, classroom)
- **Schedule/Funding Impacts**
 - Assessing impacts from Hurricanes, Fires, and Earthquakes
