Greetings NAOC!

Thank you for the incredible support of our 2019 General Membership Meeting in Scottsdale, Arizona! This newsletter shares key points from the messages I delivered during the meeting.



During the opening message on Wednesday, December 11, I explained that we, as a munitions response community, are in a time of transition. The funding supporting our industry is being aggressively challenged by emerging contaminants. We are also learning to follow new guidance affecting the implementation of munitions response projects.

As President of NAOC, I hear the concerns of industry during this time of transition. I see our membership struggle with the decrease in MMRP funding and the decline in contracting opportunities. I see our membership reposition as the risk and cost of doing business in the munition's response market has increased.

However, as President, I am a liaison between industry and our government partners. In this position, I also see the challenges the government faces due to the same forces. We are all making tough decisions about how to adapt to our future in the munition's response marketplace.

Every day, we as a munitions response community have a choice: We can be reactive during this time of transition – we can sit back and see what happens; or we can be proactive – we can try to control our path forward. From my vantage point, 2019 was the year we as a community (government and industry) began to see eye to eye and together influence what we are going to become.

Throughout 2019, DoD, USACE, and NAOC came together to constructively address polarizing issues:

- Implementation of Advanced Geophysical Classification,
- Financial challenges of performing field work in a firm-fixed price environment,
- Inconsistencies in performing munitions response work, and
- Impacts of MR-QAPP Module 1 on our work processes.

During this period of transition and uncertainty in 2019, together we created opportunity – for partnering, transparent dialogue, exchange of ideas, and exchange of grievances. We created of path forward together.

During my opening message at the Board of Directors (BOD) Meeting on Tuesday, December 10, I explained that throughout 2019, the NAOC BOD had to make tough decisions. Throughout the Board's decision-making process, we asked "WHY" a lot. I am going to share the "WHY" behind some of the major decisions taken by the BOD in 2019.

I recently sent a notification to membership about the 2020 dues increase. "WHY" do we need to raise dues? Here are a few facts:

- During our initial BOD meeting in January 2019, NAOC leadership learned our operating costs were projected to exceed our budget.
- We identified that we have not raised dues in 13 years since 2007.
- The cost of operating the Association has steadily increased each year.

The BOD considered an immediate dues increase last January to cover the cash shortfall; however, the BOD intentionally decided to not do this. "WHY?" We had a healthy cash reserve which exceeded our operating budget. We also wanted to take time to thoroughly evaluate the forces contributing to our financial decisions.

The easy path last January 16 would have been for the BOD to simply say "Let's raise dues!" Instead, our Treasurer conducted a detailed analysis the factors influencing dues: membership size structure, operating costs (including annual meeting, lobbyist fees, and day to day funding), and cash reserves.

At the end of January, the BOD reconvened and made the following unanimous decisions:

ESTABLISHED IN 1995

The National Association of Ordnance Contractors (NAOC) was established in 1995 as a non-profit organization. NAOC's objective is to act as a unified industry voice representing the issues facing its membership in the rapidly expanding business of military munitions response services.

The 21 founding members were UXO service companies. Over the years, our membership has expanded to include companies that provide and perform ancillary services to include geophysical services, detection equipment, analytical laboratories, regulatory support and related environmental/engineering services.

- Annual Balanced Budget: The BOD determined the Association must strive to annually propose a balanced budget (i.e., level of income matches expenses).
- ➤ Cash Reserves: The BOD voted to retain a cash reserve equivalent to the annual operating budget.
- ▶ Membership Structure: NAOC's primary source of income is Membership Dues. Our Membership Dues structure has been based on company size. The BOD reviewed NAOC's company size designation. The BOD upheld the "Very Small", "Small", and "Large" designations; however, changed the threshold from \$2.5M to \$5M. Going forward, NAOC's business structure will be: Very Small (<\$5); Small (<500 Employees, >\$5M); and Large (>500 Employees).
- The Livingston Group Fee: NAOC's largest fixed expense is the fee paid to our lobbyist. NAOC is fortunate to have a partnership with The Livingston Group, one of the premier lobbying firms in Washington, DC. The Livingston Group has not received a raise from NAOC in over a decade. In recognition of the vital partnership we have with The Livingston Group, the Board authorized a fee increase in 2019. The Board also set the contract to allow for bi-annual escalations to enable future Boards to adequately budget for the lobbying fees. This is documented in the 2019 contract between NAOC and The Livingston Group.

Together, our annual budget, cash reserves, membership structure, and expenses came together to create the 2020 dues structure. Ultimately, the BOD did decide to increase in 2020 by 15% in each business category.

In 2019, the BOD identified the importance of capturing the decision points influencing our dues determinations. We recognized that we are a transitional board of volunteers. Therefore, the BOD wanted to document the inputs driving our major decisions for dues, meetings, awards, etc.

We chose to capture the key components of our operating decisions into NAOC policies as follows:

- NAOC Policy 001: Duties and Responsibilities
- NAOC Policy 002: Final Audit
- NAOC Policy 003: Annual Meeting Attendance
- NAOC Policy 004: Awards
- NAOC Policy 005: Financial Guidance

I am honored to serve as the NAOC Government Affairs Chairperson for 2020. David Bell (david.bell@tetratech.com) has graciously agreed to serve as deputy Chair. Our Board of Directors sponsor will be John England (jengland@kemron.com). We are here to serve the needs of our membership, so we welcome your participation in our committee and events.

2019 was a very busy year. We had a very successful Mini and Main Fly-In meeting with over 56 Congressional Offices. Your willingness to come to DC helped gain bipartisan support for the MMRP!! The President is scheduled to sign the FY20 Defense Appropriations bill on 20 December 2019:

ER, FUDS: \$275,000,000 (+58 million)

ER, Army: \$251,700,000 (+44 million)

ER, Navy: \$385,000,000 (+49 million)

ER, Air Force: \$485,000,000 (+182 million)

ER, Defense Wide: \$19,002,000 (+10 million)

The ER plus-ups have the potential to help MMRP but, as we have seen, the decision on allocating those funds rests with the services and OSD and Congress does not weigh in at that level of detail. OSD has repeated that FUDS plus-up will be planned for MMRP.

So, your participation at the 2020 Fly-In is important as PFAS site characterizations and AFFF replacement continue to steal the spotlight. We will be meeting to finalize our FY21 legislative agenda in early January.

Our big event is the annual Fly-In, which is scheduled for 11 March 2020. Based on your feedback from last year, this will be a one-day event that will include speaker sessions and a happy hour in addition to visiting member offices.

Happy Holidays to all. Let's hope that 2020 brings all small businesses much more work and higher percentage of DoD contracts. The Small Business Committee (SBC) presents the following items for your consideration in early 2020:

- On Nov. 8, the Small Business Administration (SBA) published a proposed rule that makes significant revisions to its mentor-protégé program (MPP). This proposed rule marks the most significant revision of the program since its inception in 2016. The mission of the MPP is to help build a broad base of emerging business enterprises capable of performing high-quality construction at competitive prices. The proposed rule would have significant implications for the government contracting community, including:
 - Merging the 8(a) MPP into the All Small MPP;
 - Limiting the size of mentors to only those firms having an average annual revenue of less than \$100 million;
 - Replacing the "three in two" rule, which limits a joint venture to three contracts with a two-year time period when joint ventures can submit bids; and
 - o Allowing prime contractors to rely on self-certification of its subcontractor.
- Comments on the proposal are due by January 17, 2020.
- In late 2019, GAO noted in several reports that contracting officers generally do not monitor or enforce the requirement that the small business prime contractor must self-perform a certain percentage of the contract. The limitations on subcontracting requirements are critical to the efficacy of the small business programs. With new SBA rules set to take effect on December 30th, the expectation for enforcement is likely to be a significant focus in 2020, including the following:
 - Contracting officers (COs) may request information from small business prime contractors to demonstrate compliance with the limitations on subcontracting. There may be an uptick in solicitations that require the offeror to provide a price breakdown and narrative explanation of how the prime will meet the applicable limitation on subcontracting.
 - The type of information the CO could request under the new SBA rule includes copies of subcontracts or teaming agreements, a breakdown of the price proposal between the prime and subcontractors, or an email that lists the amount that the prime contractor has paid to its subcontractors and whether those subcontractors are similarly situated.
 - Under SBA's new rule, a small business may be found ineligible for a set-aside contract if it is
 unusually reliant on a subcontractor, even if the subcontractor is a small business or if the
 subcontractor is not a similarly-situated subcontractor (meaning the subcontractor does not have
 the small business designation required by the prime contract).

- When determining compliance with the limitations on subcontracting, SBA's new rule permits firms to exclude other direct costs to the extent they are not the principal purpose of the contract and small businesses do not provide the service.
- A prime contractor must stop counting a similarly situated subcontractor toward the prime's compliance with the limitations on subcontracting when the subcontractor ceases to qualify as a similarly situated subcontractor.
- The U.S. Small Business Administration completed a rule in 2019 that requires certification of Women-Owned Small Businesses and Economically Disadvantaged Women-Owned Small Businesses. More information can be found here:

Operations & Standards Chairman - Mr. James Salisbury

The mission of the Operations and Standards Committee (OSC) is to advise, and provide feedback to, government agencies on munitions response operations and standards issues in areas of safety, operations, personnel, and training. The committee provides an open forum to discuss current issues, reviews and distributes guidance documents, organizes technical webinars, and establishes teams as needed to address and find solutions to issues of concern to the NAOC membership. In 2019, the OSC and its members have been involved

in multiple activities, including organizing and participating in webinars, giving feedback to the government on various topics, and providing comments on government documents. The 2019 OSC comprised 52 members from 28 member companies.

In March, the OSC facilitated a webinar for the NAOC membership on MPPEH Terminology, which was presented by Mr. Jeff Brewer of the USACE EM CX. In April, OSC members also supported the M2S2 webinar on the Army Risk Management Method for assessing risks from explosive hazards, which was directed by Dr. Kari Meier, also of the EM CX. EA, ERT, AECOM, Tetratech, and Parsons participated in this informative and well-received webinar. Two more NAOC webinars followed, with the first in May providing a status on the MetalMapper 2x2 (presented by Geometrics) and the second in August presenting information on the new UltraTEM AGC sensor (presented by Black Tusk). Many thanks to Jeff Leberfinger, the Technology Committee Chair, for organizing and facilitating these two webinars. NAOC organized and facilitated a second M2S2 webinar in September with the theme of CWM response. Member companies Parsons, TetraTech, and MuniRem presented for this webinar. I am very grateful to the member companies and individuals who supported these webinars and helped to share useful information with their industry colleagues. We will be looking to continue these efforts in 2020.

2019 has also seen several new opportunities for us to provide feedback and input to the government as they develop new processes and guidance. Representatives of the OSC, along with the NAOC President and the chair of the Government Affairs Committee, met with DoD representatives in March to discuss concerns regarding the new MR-QAPP. After that, USACE reached out directly to NAOC to solicit input on issues with RFPs and performance work statements (PWSs), demonstrating how the government currently values industry involvement. More recently, NAOC was given the opportunity to provide comments to USACE concerning EM 200-1-15, Technical Guidance for Military Munitions Response Actions, in advance of its coming update. Having the opportunity to provide comments in advance of the update was a first for NAOC and indicates the strength of our relationship with the government regarding ongoing dialogue on matters concerning the munitions response industry. Throughout 2019, the OSC has also worked with the Government Affairs Committee to provide ongoing feedback to the government regarding impediments to success and inconsistencies in the ways different organizations approach munitions response projects. Examples of these issues include comments on

the UXO technician database and TP-18, both of which have resulted in the government taking action. The OSC also supported Jeff Leberfinger and the NAOC Technology Committee with a further government/NAOC meeting to discuss the status of AGC that took place in November. I anticipate maintaining these strong working relationships into next year and look forward to providing continued input to our government partners.

With regard to the MR-QAPP, as a result of NAOC's discussions with the government, the OSC arranged for four industry representatives to attend a meeting in April, where they supported the development of the future training program for the MR-QAPP. The government indicated they found NAOC's participation in this meeting extremely helpful. OSC members AECOM, EA, Jacobs, and ISSI took part in this effort and provided excellent feedback on behalf of NAOC. Following this training development meeting, 10 people from member firms attended the first training session for the new MR-QAPP, which was held in Denver in mid-July, and a further 10 people attended a second training class in Baltimore in November. Most recently, 50 NAOC members attended the MR-QAPP training that followed this year's annual meeting in Scottsdale in December.

The OSC has also acted as a government POC to facilitate the distribution of new guidance to the industry. In 2019, this has included the MR-QAPP Toolkit, Module 1: RI/FS (December 27, 2018), the Defense Explosives Safety Regulation (DESR) 6055.9, Ed. 1 (January 13, 2019), and the Guam "Risk Acceptance Letter" (January 24, 2019). In 2020, we expect to see the next version of EM 200-1-15, Technical Guidance for Military Munitions Response Actions, and have another opportunity for member firms to offer comments and feedback.

The success of the OSC is the result of the active involvement of our members and I appreciate everyone's participation in 2019. I would also like to thank the Technology and Government. Affairs Committees, particularly Jeff Leberfinger and Victoria Kantsios, for their support and working with the OSC on all manner of efforts this year. I also want to acknowledge our NAOC President, Lanette Waite, whose outstanding leadership and support has been invaluable to the OSC's success.

We will continue to welcome new members, ideas, and topics for discussion, so do not hesitate to offer feedback and/or suggestions if you have them. The OSC will hold monthly meetings in 2020, so please contact me if you would like to be added to the OSC roster.

The National Association of Ordnance Contractors (NAOC) is partnering with the Environmental and Engineering Geophysics Society (EEGS) and European Association of Geoscientists and Engineers (EAGE) to offer the meeting in conjunction with the Symposium on the Application of Geophysics to Engineering and Environmental Problems (SAGEEP). There will be over 70 Munitions Response (MR) related presentations given by industry and government on a wide variety of MR topics.

There are currently 14 firms that have achieved their DoD Advanced Geophysical Classification Accreditation Program (DAGCAP) ISO 17025 accreditation. Since the last update InDepth Corporation and Janus Global Operations LLC received their accreditation. Several other firms are reported to be working on their DAGCAP certification. During the summer of 2019, the DAGCAP and USACE asked for feedback from NAOC regarding questions, challenges, and comments on implementing Advanced Geophysical Classification (AGC) on projects. The Technology Committee received and submitted approximately 80 comments and questions on AGC from NAOC to DAGCAP and USACE on September 3rd. An in person partnering session was held to discuss the AGC questions and comments with the DAGCAP Geophysical Classification Organizations (GCOs) and NAOC representatives on Monday, November 18th. The meeting was moderated and hosted by Lanette Waite, at TetraTech's Arlington, Virginia office. There was good dialogue during the meeting on both technical and programmatic topics. Detailed minutes were taken by NAOC to document discussions and action items that came out of the partnering session. Meeting minutes are being prepared and circulated for review and will be made available to NAOC once finalized.

On October 21st Geometrics released a new data acquisition software Version 2.0 for the MetalMapper (MM) 2x2 to address critical comments from Industry and DAGCAP. One of the new features is an infield inversion which will reduce the number of recollects needed, reducing risk and time for AGC data collection using the MM 2x2. Additional upgrades include, 1) improved file naming to meet DAGCAP requirements (including SBR and SFT measurements), 2) Sensor Function Test calculation now matches Geosoft's calculations, and 3) the ability to set acquisition parameters (i.e., GPS height, sensor height, and target proximity limit). An NAOC webinar held on May 14th with Nick Odlum of Geometrics discussed the new features and improvements in the new data acquisition software release. Geometrics also released a Technical Bulletin on the Importance of Valid Background Measurements with the release of the Version 2.0 data acquisition software.

GapEOD/BlackTusk had a successful test of their new UltraTEM (photo below) in late July at the Aberdeen Proving Ground (APG) DAGCAP Test Site. Following this test, the UltraTEM was approved by DAGCAP for use on AGC projects. GapEOD/Black Tusk are aiming for production rates similar to those typically achieved by an EM61 towed array, but with higher resolution data that supports informed source selection (ISS) methods and one pass classification. GapEOD/BlackTusk plans to provide service with a transition to leasing/renting the UltraTEM to DAGCAP GCOs for projects. GapEOD/Blacktusk provided a NAOC webinar on the UltraTEM on August 21st. The Strategic Environmental Research and Development Program (SERDP) and the Environmental Security Technology Certification Program (ESTCP) Symposium was held in Washington, DC, from December 3rd through the 5th, 2019. The two primary Munitions Response sessions were on Systems for Detection and Classification of Underwater UXO and Burial and Mobility Studies of Underwater UXO. In addition, there were several short courses and more than 450 technical poster presentations, with more than 1,000 attendees. MR ESTCP Project of the Year was awarded to Acorn SI for "Efficient and Secure Cloud Computing for UXO Classification and Project Management." Dean Keiswetter, a current NAOC Board Member is the principle investigator on this project. 

NAOC Annual Leadership Award

Each year, NAOC selects two highly qualified individuals as recipients of its Leadership Award, one representing government and the other representing industry.

Government Leadership Award: John Jackson

Mr. Jackson is a true subject matter expert in his field and a recognized leader within Government and Industry. He works extensively within the MMRP program to ensure consistency and knowledge sharing between all DoD components and regulators to include development and application of current guidance, and implementation of new technology.

Mr. Jackson has worked diligently with the industry to advance the AGC technology and communicate its application. He has partnered with NAOC on numerous occasions and, in particular, he has forged a working relationship with the Technology Committee. He has
