Hello and welcome to 2017! The Small Business Committee is looking forward to an exciting yet what may be a challenging year with a new administration moving into new government roles. No matter whether it's a new administration or not, the challenges for small businesses to conduct business, gain market share, and grow are always present and that is why we need for you to join and participate in the Small Business Committee (SBC). Whichever socioeconomic model your company fits into, the SBC is the place to discuss the small business marketplace. Our meetings occur once a month and we are always looking for new members. Please let me know if you're interested.

A few items of interest for small businesses that occurred late in 2016 and early 2017 include the following:

- The SBA is conducting the third year of the InnovateHER: Innovating for Women Challenge ("the Challenge"), pursuant to the American Competes Act, for entrepreneurs to create a product or service that has a measurable impact on the lives of women and families, the potential for commercialization, and fills a need in the marketplace. The Challenge launched on December 29, 2016. The initial round of the Challenge will take the form of local competitions that will be run across the country beginning December 29, 2016, and ending no later than April 29, 2017. - The Small Business Jobs Act of 2010 and the National Defense Authorization Act for Fiscal Year 2013 provided authority for the Small Business Administration to establish mentor-protégé programs for all small businesses. Rather than creating separate programs for each constituency of other socioeconomic groups, the SBA chose to create a single, all-inclusive mentor-protégé program modeled on the successful mentor-protégé program available to participants in its 8(a) program. As of November 1st, SBA's https://certify.sba.gov portal is operational and accepting applications for the new Small Business Mentor-Protégé program. - At the tail end of 2016, SBA delivered its long-awaited Final Rule regarding lower-tier small business subcontracting plan credit. The SBA is amending its regulations to implement section 1614 of the National Defense Authorization Act for Fiscal Year 2014 to provide that where a prime contractor has a subcontracting plan for a specific prime contract with an executive agency, as required by Section 8(d) of the Small Business Act, the prime contractor will receive credit towards its subcontracting plan goals for awards made to small business concerns at any tier under the contract, to the extent reported under the subcontracting plan of a lower tier other than small subcontractor. <u>https://www.federalregister.gov/documents/2016/12/23/2016-30874/credit-for-lower-tier-small-business-subcontracting

OSC partners with the Technology Committee to present a webinar series. We target 4-6 webinars to deliver to our membership throughout the year. Between our webinars and M2S2, our membership can participate in a free, top quality, informative webinar at least 8-10 months of the year. Message from our Technology Chair – *Mr. Jeff Leberfinger, TerranearPMC LLC* JLeberfinger@TerranearPMC.com

The Technology Committee will continue to provide information to the NAOC membership on technology updates that impact the member companies and the industry. Craig Murray of Parsons will serve as the Deputy Technology Committee Chairman. This year we have 62 members on the committee representing 37 member companies. We will also continue to work with the NAOC Board and all the committees providing support on technological issues.

Geosoft Inc. (Geosoft) and Acorn Science & Innovation, Inc. (Acorn) in conjunction with Environmental Security Technology Certification Program (ESTCP) are working on a new version of UX-Analyze. The new version of UX-Analyze is expected to be released tentatively in February or March. The new version will include all the new UX-Analyze features, such as a more efficient work flow and tools for dynamic target picking. Once the release date is set, a UX-Analyze training session will be planned for 2-3 days in Denver, Colorado sometime later in the spring. As soon as registration information is available it will be provided to NAOC member companies. The class size will be held to approximately 25 attendees. If there is sufficient interest, a second session will be held at a date and venue to be determined.

Geometrics (who has joined NAOC as a new member company) has sold 4 MetalMapper 2 x 2 systems to Arcadis, CH2M, Exploration Instruments, and Parsons. Geometrics is currently working with these companies and industry experts to work out bugs in the software and hardware. Testing of the new MetalMapper 2 x 2 updates will be performed at Blossom Point in February by ch2m and Arcadis. An update on the current status of the MetalMapper 2 x 2 will be presented on the March 1st Technology Committee Call and will present a more detailed history and details of the MetalMapper 2x2 at the SAGEEP conference the week of March 20th, 2017.

The DoD Advance Geophysical Classification Accreditation Program (DAGCAP) Root Cause Analysis training for NAOC has been set for March 13, 2017 at the A2LA facility in Frederick, Maryland. The format will be similar to the previous DAGCAP QSR training with the training being done by the two DAGCAP Accrediting Bodies' (LAB and A2LA) and EDQW and DoD. The class would be geared for anyone who would be working on root cause analysis for DAGCAP projects including PMs, Project and QC Geophysicists, and DAGACP quality managers. The class will be one day in duration. There is a \$75 per person fee. The registration link for the root cause training is now active <u>http://www.cvent.com/d/kvqg6y/4W</u>.

In moving forward, I would like to extend an invitation to the NAOC membership to become involved with this committee. We will be scheduling conference calls to gather on a regular basis, with the first of these meetings scheduled for Tuesday, 14 February.

I want to take this opportunity to thank you in advance for allowing me to serve NAOC, both through election to the Board and through leadership of this committee. There are many exciting things coming, and we need to work hard to keep NAOC positioned to support these international needs.

Message from our Government Affairs Rick Hanoski - <u>rhanoski@eaest.com</u> (Interim)

GAC now consists of two tiers. The first tier consists of five members the Chairperson, and four volunteers from the Board of Directors. Those members are Ben Redmond (HHUX LLC), Matt Hulsey (Janus), David Bell (Tetra Tech), Ryan Steigerwald (Weston), and myself (Chairperson). The second tier is comprised of members from within the membership. You will see a call for GAC members prior to the next GAC meeting. This reorganization was made in order to better focus on the association governmental concerns and utilization of The Livingston Group.

The GAC goals this year are a bit different than in the past. As always, sustained funding is a standard without saying and that the MMRP budget is generally underfunded with respect to the overall liability. Another topic is make our legislators aware of the trend we are seeing in government to use "Low Prices/Technically Acceptable" (LPTA) in Federal contracting. LPTA paired with Performance Based Acquisition is a dangerous combination for our members. I would recommend that our membership review the Memorandum from the Under Secretary of Defense dated 04 March 2015 and in the DoD Source Selection Procedures dated 01 April 2016.

Another concern and goal is the MMRP budget in the Environmental Restoration (ER) Account. We have looked at the historical Installation Restoration Program (IRP) and Military Munitions Response Program (MMRP) budget plans vs obligated funds (budget plans is always higher and obligation lower) with respect to overall funding levels, plus ups, etc., and will lobby Congress on that fact. Our concern is that the timeline for MMRP (the famous "X" Chart) is continually moving to the right due to the delays in the IRP close out, and with the emerging contaminants eventually merging into DERP (as we heard from the Armed Services committee), the issue is going to balloon over the next year and the overall DERP account will be expended to combat those issues versus explosive hazards.

Capital Fly-in Mar 2017

Our Annual Fly-in is next week! With a new Congress and Administration, this year will be an important one to enhance NAOC's visibility and raise awareness of the issues of importance to its members. The annual fly-in will take place in Washington, DC on March 7-8 and will consist of presentations on the political landscape as well as the military munitions response industry. We will also schedule Hill visits to Congressional offices to promote NAOC priorities and raise awareness of the work our members are doing in a large number of states and congressional districts. This is a great opportunity to promote NAOC and our agenda. I am sure you will find participation very rewarding and worthwhile.

We ask that you please participate in the Fly-In. Your voice and presence is key in accomplishing our association goals. As you know, there are a lot of groups that are always in front of our legislators and if we don't stand up for our industry and follow up, then our voice and concerns will not be heard.

We look forward to seeing you in March for the Fly-In and pass the word, more the merrier!
