NAICS Codes and Small Business Sizes: Are you familiar with your company's size? To assist small business owners with understanding their small business status, the U.S. Small Business Administration (SBA) has established a Table of Small Business Size Standards ([see table](#)), which is matched to the North American Industry Classification System (NAICS) for industries. The current table of size standards is based on the 2017 NAICS.

The SBA updated its table of small business standards, adopting the U.S. Office of Management and Budget's NAICS revision for 2017, which created 21 new industries by reclassifying, combining, or splitting 29 existing industries under changes made to NAICS in 2012 (NAICS 2012). You can find the updated information here: <https://www.census.gov/eos/www/naics/>

SBA's size standards for these 21 new industries resulted in an increase to size standards for six NAICS 2012 industries and part of one industry, a decrease to size standards for two industries, a change in the size standards measure from average annual receipts to number of employees for one, and no change in size standards for 20 industries and part of one industry. *The updated size standards became effective October 1, 2017.*

You may read/download SBA's final rule at www.regulations.gov (search on "RIN 3245 AG84" [without quotes]). You may also review the proposed rule together with all of the public comments by going to www.regulations.gov. The proposed rule and the comments are included in the same docket.

SBA is in the process of launching the second 5-year review of size standards. As part of that effort, the Agency will first publish its revised “Size Standards Methodology” white paper for public comments. Once the revised methodology is finalized, SBA will start reviewing the size standards and issuing proposed rules for comments. The SBA 8(a) Program: In a recent decision, the SBA Office of Hearings and Appeals (OHA) held that the SBA may terminate a participant from the 8(a) Program for failing to provide the required information—even if the 8(a) company’s owner has had personal difficulties that contributed to the failure. Therefore, participants in the SBA’s 8(a) Program must timely submit their annual review packages to the SBA.

In a recent case, a Michigan-based small business received a Termination Letter from SBA. In the letter, the SBA stated that the company would be terminated from the 8(a) Program because of its repeated failure to submit the required annual review information. The 8(a) company filed an appeal noting personal difficulties for the owner. However, OHA noted that the SBA’s 8(a) Program regulations allow the SBA to terminate a participant for “[a] pattern of failure to make required submissions or responses to SBA in a timely manner,” including the timely submission of annual review information. In this case, the company “admits the violation and confirms SBA’s grounds for termination.” It is “of no consequence that the company’s violation was not intentional.” OHA dismissed the appeal.

As the case demonstrates, the SBA takes the 8(a) annual review very seriously. Although it’s an area of broad discretion, the SBA has the right to terminate a company from the 8(a) Program for repeatedly failing to submit the annual review information, or other relevant information requested by the SBA – even if the 8(a) owner’s personal troubles made compliance more difficult.

In other recent news, the SBA 8(a) program recently survived a constitutional challenge. However, due to the recent litigation, the program is open to further legal challenge. Message from our Operations and Standards Committee Chair -

Greetings from the Operations and Standards Committee (OSC)!

During the last quarter of 2017, the OSC has been focused on developing a phone-based application to provide UXO Technicians with a convenient tool for tracking their work hours, MEC-related tasks, and certifying their work hours. We researched electronic delivery platforms, sought cost proposals, and polled the membership for its interest regarding use and investment in an electronic product. Based on the results of our survey, the decision has been made that NAOC is not going to continue to pursue the development of an iphone-based application. We have posted a template for hardcopy UXO logbook page on our NAOC website. Member companies are welcome to use the template.

The OSC has partnered with the Technology Committee to evaluate quality control criteria for analog methods. By the end of November, we will deliver a whitepaper to the munitions response workgroup developing the draft Munitions Response Quality Assurance Project Planning (MR QAPP) guidance. This whitepaper will represent NAOC's evaluation and recommendation for analog QC criteria.

In December, we are anticipating the opportunity to a review the draft MR QAPP. The MR QAPP will eventually become the guiding document for RI/FS projects. When the draft is available for review, I will send an email soliciting comments from the membership. I strongly encourage your company to take the opportunity to provide comment on this document. Also, Dr. Jordan Adelson (Chair DoD Environmental Data Quality Workgroup) will be providing a QAPP workshop at the NAOC Membership meeting from 1500-1700 on Tuesday, December 5, 2017.

We have concluded our webinar series for 2017. We welcome suggestions for topics and speakers in 2018.

The following guidance updates were issued this quarter:

- OP-5 Change 14 issued 1 June 2017
- DDESB Fragmentation Data Review Forms Database: Updated version is dated July 19, 2017. DDESB also issued a summary of changes to accompany this update.

The OSC welcomes new members, ideas, and topics for discussion. Our meetings are held on the first Wednesday of each month at 1pm EST. Please contact me if you would like to be added to our Committee roster.

The Technology Committee has continued to provide information to the NAOC membership on technology updates that impact the member companies and the industry.

Since the beginning of 2017 seven firms have achieved their DoD Advance Geophysical Classification Accreditation Program (DAGCAP) ISO 17025 accreditation;

1. Parsons Corporation
2. Acorn SI and NAEVA Joint Venture
3. CH2M Hill, Inc.
4. Black Tusk Geophysics
5. Arcadis U.S. Inc.
6. Tetra Tech EC
7. APTIM Federal Services LLC

Based on information from other firms at least 2 additional firms are expected to be accredited by December 2017. The up to date list of DAGCAP accredited firms can be found on the Denix website at: <http://www.denix.osd.mil/mmrp/advanced-geophysical-classification-accreditation-and-other-tools/>.

On September 27th and 28th validation testing of the MetalMapper 2 x 2 (MM 2 x 2) was performed at the Aberdeen Test Center, at the Aberdeen Proving Grounds in Maryland. The objective of the effort was to validate the performance of a MM 2 x 2 under blind test conditions. The Aberdeen Test Site is blind seeded with metallic items to be representative of a real UXO site for the DAGCAP. The data was collected by Dan Steinhurst and Glen Harbaugh of Nova Research Inc. using Exploration Instruments Inc.'s MM 2 x 2. The performance of the unit under dynamic data collection conditions was evaluated over approximately a half-acre of terrain seeded to represent a real UXO site. The performance of the unit under static data collection conditions was evaluated over 99

previously-located anomalies within a site seeded to represent a real UXO site. In both cases, the data were processed by Tom Furya of Acorn Science and Innovations Inc using the Geosoft Oasis Montaj / UX-Analyze tool suite and procedures. The version of UX-Analyze used had some bug fixes that aren't in the current release. These fixes will be in the next release which is scheduled for November from Geosoft. Detection and classification lists were generated and submitted for scoring by two independent sources. Based on scoring, the data collected with a MM



2x2 were of sufficient quality to detect all expected Targets of Interest (TOI) on a site seeded to be representative of a real UXO site. Also, based on the scoring results, the data collected with the MM 2x2 were of sufficient quality to classify 99 previously detected anomalies. The testing indicated that in dynamic data collection mode, the unit can operate under ambient conditions for 1 – 3 hours before a significant rest break is required because of system overheating. Geometrics is currently working on a fix to reduce the heating issues with the system. Recommendations for additional improvements for overall system durability were also made by the evaluation team and provided to Geometrics.

The Environmental and Engineering Geophysical Society (EEGS) would like MMRP geophysics to be one of the focus areas of their Symposium on the Application of Geophysics to Engineering and Environmental Problems (SAGEEP) conference next year (March 25th – 29th) in Nashville, TN. There are seven planned MMRP related sessions:

- Perspectives on MMRP Geophysics
- Recent Results in Marine Acoustic Methods for Detection and Classification
- Non-acoustic (EM and other) Methods for Marine MEC Detection and Classification
- Land and Underwater Positioning; state of the art and recent advances
- Lessons Learned from ESTCP Live Site Demonstrations
- Site Application of Classification Technologies – contractor experiences both good and bad
- Innovative Applications of Geophysics on MMRP Projects

Bill Doll (TetraTech) will be the general chair for the conference and leading the effort with support of Technology Committee. Abstracts are being accepted until November 3rd, 2017. For more information on the conference visit: <http://www.eegs.org/sageep-2018> .

The two primary Munitions Response sessions will Systems for Detection and Classification of Underwater UXO and Burial and Mobility Studies of - Underwater UXO. Mark your calendars for March 13-14, 2018, the dates of the NAOC 2018 Fly-In. . This year we will be holding the reception on the evening after the Congressional meetings. This will allow NAOC members to personally invite members and staff to the reception later that evening. TLG is working on the date for the mini fly-in in 2018 as well. Once the Congressional calendar is released (usually in December) we will be firming this up.

Concerning the budget Congress is still working to reach a final budget agreement (currently operating under a Continuing Resolution through December 8) and Defense Authorization should be finished sometime before the end of the year. So, more to come on that.

The DoD is in the process of writing a rule on LPTA in compliance with last year's National Defense Authorization Act. As you may know, NAOC submitted a paper to The Defense Procurement and Acquisition Policy (DPAP) office to have MRS services exempt from LPTA procurements. The DPAP

office had received NAOC's comments and should be issuing a rule on this matter in the coming weeks hopefully in time for our membership meeting. If we do not get a favorable outcome from this, then the association will be recommending a different path to reach this objective. Fingers crossed!

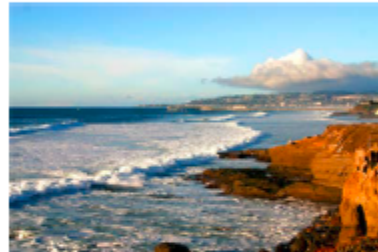
